**Sub: Issue of Recognition Certificate to schools as per Right of Children to Free and compulsory Education Act, 2009, Section 18, Right of Children to free and compulsory Education Act 2011- Rule- 11, Subsection (4)**

Sir,

In reference to your Application dated 06/05/2023 and subsequent correspondence done with school or inspection done at school, I Education officer (Primary) Raigad District Council, Alibag From date 15/05/2023 to date 14/05/2026 i.e, for a period of 3 years, is giving temporary approval to Std. 1st to 8th of NJBSPM's Shantiniketan Public School. Sector - 2, New Panvel Tai, Panvel, Dist Raigad, English Medium Above mentioned approval with subject to below mentioned conditions:-

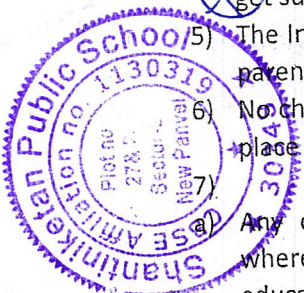
- 1) The validity period will not be extended and there will be no binding to give approval or affiliation after standard 8<sup>th</sup> in any condition.
- 2) School will follow regulations as per Right of Children to Free and Compulsory Education Act, 2009 (Annexure 1) and Right of Children of Maharashtra to Free and Compulsory Education Act, 2011 (Annexure 2)
- 3) The School will give admission to nearby children from weaker sections and will give them free and deprived sections in 1<sup>st</sup> Standard upto 25% of the total Children of that Standard and will give them free and compulsory education till completion of their primary education. Moreover such provisions will also be observed for pre-primary classes.
- 4) As per Act section 12 (2), the children as mentioned in Para no - 3 will be given reimbursement and to get such reimbursement, the school will be provided with separate bank account.
- 5) The Institution or school will not collect any capitation fee and will not compel children and his or her parents or guardians for any selection procedures.
- 6) No child will be denied admission in the school due to lack of proof of age, religion, cast or race, birth place or any of these.
- 7) Any child who has taken admission in the school will not be detained in the same standard where he will be at that point or will not be expelled from the school before completion of his primary education
- a) No child will be mentally or physically abused.

- c) No child will be required to pass the examination conducted by any board prior to completion of his/her primary education.
- d) Every child will be granted certificate laid down under Rule- 23 after completion of his/her primary education.
- e) Inclusion of handicapped/ children with special needs will be accommodated as per the provision of the Act.
- f) Appointment of teachers with minimum qualification requirement will be done as per Act 23 (1) however, those teachers who do not have minimum qualification should acquire it within a period of 5 years.
- g) The Teachers will perform his/her duties as specified in the Act, Section 24 (1).
- h) The School will make sure that the teacher does not involve himself/herself in private coaching/tuitions.
- 8) The school will follow the syllabus prepared by appropriate authorities.
- 9) The school will admit students according to the available facilities at school as per Act, section 19.
- 10) The school will follow the standards proposed as per Act, section 19. Following are the facilities available in the school at the time of last inspection
- Area of school premises-2.25 acres
  - Total construction area-3986.59 Sq. meter
  - Area of Playground-5080 Sq. meter
  - Number of classrooms-49
  - There is an office, a storeroom, and a principal's room-Yes
  - Separate toilets for boys and girls with sufficient water and keeping toilets in clean and hygienic condition - Yes
  - There is a drinking water facility - Yes
  - There is a kitchen for cooking lunch-No
  - Availability of Teaching Study Materials/Sports and Sports Material/Library-Yes
  - Reading material is freely available - Yes
- 11) The classes or Divisions not approved will not be allowed to run in the school premises or elsewhere.
- 12) The school building or other construction and playground shall be used for education and skill development only.
- 13) The school is run by organization registered under societies Registration Act, 1960 (Act No. 21.) and the Bombay Public Trust Act, 1950.
- 14) The school is not run for profit of any individual group or organization.
- 15) The accounts of the school should be certified by chartered accountant and appropriate accounting statement should be prepared as per rules Copy of each accounting statement should be sent annually to the education officer.
- 16) Your school's Recognition no. is **RTE-27240818868** and please keep note of this for any further correspondence.
- 17) The school should submit report that are asked from time to time by Deputy Director of Education / District Education Officer and should follow instructions given by government or local authority and comply to the proposed suggestions given to the school and remove any work related errors.
- 18) The renewal of registration of organization should be assured.
